On the 17th day of November, 2022, at 10:30 AM, a regular meeting of the Kenedy County Groundwater Conservation District was held at Kenedy Memorial Foundation Carriage House in Sarita, TX.

1. Call Meeting to Order

Edward Bordovsky, President, called the meeting to order at 9:15 AM and announced that a quorum was present.

2. Public Comments

No comments were received.

3. Discuss & Act on Minutes of October 19, 2022 Regular Meeting

President Edward Bordovsky presented to the Directors the minutes of the October 19, 2022 regular meeting.

Sonny Burns moved and Verl Cash seconded the motion; the motion passed unanimously that the minutes of the October 19, 2022 regular meeting be approved as presented.

Andy Garza, General Manager, reported on the following:

- a. Communications: Garza reported that since the District's October, 2022 meeting, he had communicated with Kristen Fancher, Kenedy County GCD legal counsel, regarding the possibility of attending our GCD meeting in December, 2022; Stan Floyd, Kenedy County landowner, regarding the availability of cost-share assistance for a new water well; Robert Schmidt, Kleberg-Kenedy SWCD clerk, regarding cost-share assistance for water wells; Ricardo Chapa, TSSWCB regional manager, regarding cost-share assistance for water wells; Adalberto Garza, Starr County GCD assistant, regarding an Agrilife Extension meeting being held in San Isidro, TX; Sean Sahs, database specialist, regarding downloading data in GCD database and Cale Applegate, Big Horn Ranch manager, regarding the registration of a new water well.
- <u>b. Well registrations</u>: Garza informed the Directors that he will be working with Cale Applegate to register a new water well on the Big Horn Ranch.
- c. Brush Country GCD meeting: Garza reported that the Brush Country GCD had met on October 25, 2022 and reviewed the highlights of the meeting.
- <u>d. Duval County GCD meeting:</u> Garza stated that the Duval County GCD had met on October 26, 2022 and covered the highlights of the meeting.
- <u>e. GMA-16 Update:</u> Garza reported that GMA-16 had posted a Request for Qualifications for hydrology specialists.
- <u>f. Drought report:</u> Garza shared with the Directors the latest drought report from the U.S. Drought Monitor.
 - g. Region N newsletter: Garza handed out to the Directors the latest Region N newsletter.

h.Desal plant visit for January, 2023: Garza reported that he will try to schedule the visit to the Brownsville, TX desal plant on the second Tuesday of January, 2023.

- j. Need for records storage space: Garza reported that the Kenedy County GCD will be needing additional records storage space in the near future. Danny Butler suggested that this item be considered at the December, 2022 meeting.

Danny Butler moved and Sonny Burns seconded the motion; the motion passed unanimously to accept the General Manager's report and approve the Thanksgiving dinner to a needy family at a cost not to exceed \$100.00.

5. Discuss & Act on Approving 2022 Budget Amendments

Andy Garza recommended the following budget amendments: transfer \$3,000.00 from "Well Monitoring" to "Audit", transfer \$200.00 from "Public Education Brochure to "Bank Charges", transfer \$400.00 from "Public Education Brochure to "Dues and Subscriptions" and transfer \$200.00 from "Public Education Brochure" to "Office Telephone".

Esteban Lopez moved and Sonny Burns seconded the motion; the motion passed unanimously to approve the 2022 budget amendments as recommended by Andy Garza.

6. Discuss & Act on Adopting Records Management Policy for Kenedy County GCD

Andy Garza presented to the Directors a Records Management Policy based on a template provided by the Texas State Library and Archives Commission and asked for its approval along with Forms SLR 504 and SLR 508. Garza stated that the General Manager will serve as the Records Management Officer for the GCD.

Sonny Burns moved and Esteban Lopez seconded the motion; the motion passed unanimously to approve the Records Management Policy as presented.

7. Discuss & Act on Authorizing Kristen Fancher to Review RWE Permit Application

Andy Garza reported that in the past Mary Sahs had written all the permits for the Kenedy County GCD and suggested that Kristen Fancher be authorize to review the permit currently being written for the RWE wind farm. Garza stated that this would give Mrs. Fancher the opportunity to familiarize herself with district rules and permits.

Verl Cash moved and Danny Butler seconded the motion; the motion passed unanimously to authorize Kristen Fancher to review the permit being written for the RWE wind farm.
